

BENEFITS OF INTEGRATING MANAGEMENT SYSTEMS FOR RESPONSIBLE ELECTRONICS RECOVERY

Making the decision to implement a management system and become certified is not always easy, but once made – how far do you go? While there are some differences, the chart below demonstrates the significant overlaps between the four common standards applied in the electronics recovery sectors.

The e-Stewards Standard has the most extensive requirements of any of the standards and is therefore an excellent basis for achieving certification to the other three. In most cases integration makes sense and is very cost effective as it streamlines implementation, training, auditing and certification costs, while giving significantly greater validation of responsible practices.
